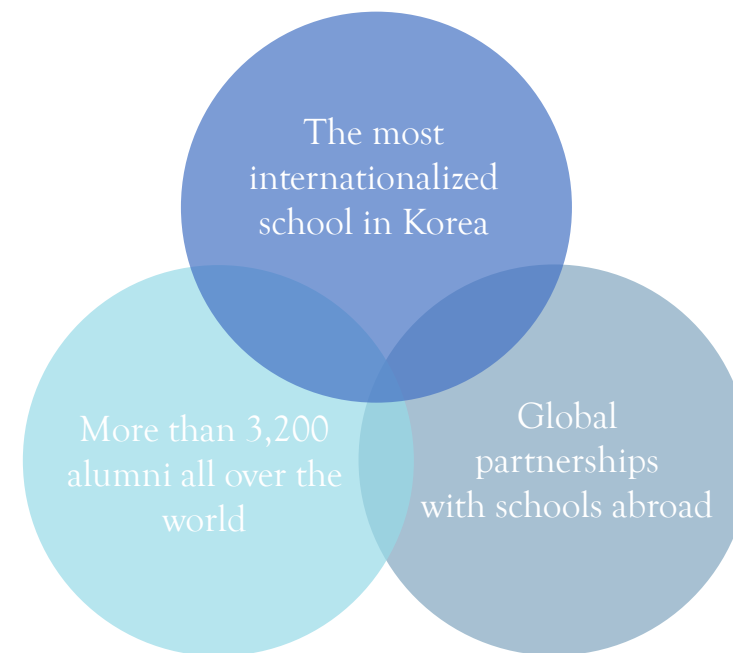

The Graduate School of International Studies lies at the center of Yonsei's commitment to internationalization and education of global leaders. Founded in 1987 as the first professional school in Korea, Yonsei GSIS was to meet the growing demand for international experts in the nexus between the political, economic, and cultural worlds. Yonsei GSIS has paved the way for Korea's accelerating globalization by educating, training, and mentoring leaders for the 21st century. With 17 full-time, distinguished, and adjunct faculty members and over 300 students (M.A. and Ph.D. candidates), the GSIS has produced 3,244 graduates. 66% of GSIS students are from abroad: the highest percentage of any professional education institutions in Korea. International students from 53 countries provide a unique multicultural learning environment where diversity is not just a slogan but an enduring feature of the school's globalized student culture.
